The Cookie Policy (hereinafter referred "The or This Cookie Policy") is proposed by the company WFS GLOBAL SAS, a simplified joint stock company with a capital of 99,987,000 euros, registered before the Trade and Companies Register of Paris under number 491 807 558, whose registered office is located at 7 boulevard de la Madeleine, 75001 Paris. (The company WFS GLOBAL SAS is hereinafter referred to as "the Company").

The Cookie Policy informs about the deposit and use of cookies on the website (hereinafter this or our "Website"): <https://www.wfs.aero/> published by the Company.

I. INTRODUCTION

In accordance with Article 82 of the French Law "Loi Informatique et Libertés" dated January 6, 1978, as amended, adopted pursuant to the provisions of the European Directive 2002/58/EC on the processing of personal data and the protection of privacy in the electronic communications sector, your consent as User must be collected before any action to store information or access information stored in your terminal equipment.

II. WHAT ARE COOKIES?

A cookie is a data file created by the server of the website, saved to the hard disk of your device (computer, smartphone, etc.) by the browser.

The cookie contains a unique code that recognizes your browser when you visit the website from now and in the future.

The main purpose of a cookie is therefore simply to allow the website server to adapt the content of the Internet pages to your personal preferences, in order to personalize your visit to this website.

Cookies may be placed by the website's server or by partners that the website may collaborate with.

The website server can only read the cookies that it has placed itself.

It cannot access any other information on your computer or on your mobile device.

Cookies generally facilitate interaction and enhance browsing speed.

The website may therefore use several types of cookies:

- Session cookies: these cookies are temporary and stored in your browser until it is closed. These cookies are mandatory for certain applications or features of the website to work properly.
- Persistent cookies: the website may use persistent cookies to improve your experience (e.g. by providing optimized navigation). These cookies remain in your browser longer. The duration of their storage depends on the configuration choices of your Internet browser. Persistent cookies allow the transmission of information to a web server each time a person visits the website, and may be used in particular to remember your preferences and choices for a website, or to target advertising. Persistent cookies are also called tracking cookies.
- Internal cookies : these cookies are installed by the website at the time of your visit in order to improve your experience.
- Third-party cookies : these cookies are installed by third parties who may be partners of the Company. A third-party cookie corresponds to a file integrated via a browser by a site different from the one you visit, in order to store information locally and track your progress on several sites. These cookies are therefore not hosted on the website.

These cookies are classified according to several types: necessary cookies used for technical purposes, audience measurement cookies, advertising cookies, sharing cookies on social networks, etc.

III. WHAT ARE COOKIES USED FOR?

Cookies are used for different purposes:

- Functional cookies : they are essential for the operation of the website and allow you to access particular secure spaces such as your shopping cart, your personal space, personalize services by remembering your preferences (choice of language, currency, location, etc.)
They do not require that you restate your choices every time you visit the website. These cookies allow you to store the choices you make in order to improve your experience on the website.
They are for example used to recognize you when you return to the website, to remember the choices you have made, the items you have placed in the cart etc... and provide improved and personalized elements on your preferences and consumption habits.

- Analytical or performance cookies : these cookies allow the Company to track the use and performance of the website and to improve its functioning. They make it possible, for example, to know the most visited pages of the website, store the information you provide on online forms, do statistical analyses (e.g.: the number of unique visitors), analyse website traffic and the popularity of our pages.

These cookies are intended to facilitate and analyse the functionality of our website and to make it easier to use and offer a more personalized user experience.

- Advertising cookies : these cookies collect information about your browsing habits in order to present you with advertisements tailored to your interests. These cookies record your visit to the website, the pages you have visited and the links you have followed as well as your browsing outside the website. They are also used to limit the number of times you see the same ad and to measure the effectiveness of advertising campaigns.

They are generally placed on the website by third parties with the permission of the Company.

V. WHAT PERSONAL DATA IS COLLECTED BY COOKIES?

Cookies used on this website collect the following personal data :

- IP address (a number that identifies our computer on the network), ;
- Brands and version of our browser ;
- Date and hour of your website visit ;
- The most recent web page viewed.
- The operating system ;
- Internet provider.

VI. HOW LONG ARE PERSONAL DATA COLLECTED BY COOKIES KEPT?

Personal data collected through cookies on this website are kept for a maximum of thirteen (13) months.

Cookies can be kept for a maximum of twenty-four (24) months.

Your choice to accept or not the deposit of cookies on this website will be kept for a period of twenty-four (24) months.

VII. HOW DO YOU CONSENT TO THE COOKIES PLACED ON THE SITE? (VIA THE COOKIES BANNER)

The first time you connect to this website, an alert message (banner) informs you of tracers / cookies used on this website by the company and partern's company.

You are invited to accept or refuse these tracers/ cookies.

Accepting or refusing cookies has no effect on your browsing on the website, with exception of cookies that are strictly necessary for the running of the website or for an online communication service that you have requested.

The company also uses cookies to guarantee access and important functionalities of the website (functional cookies). These cookies do not require your consent.

If you block functional cookies, you will no longer be able to benefit from a certain number of functionalities which are, however, necessary to navigate some of the pages on the website : for example, when we, or our service providers, cannot recognize, for technical reasons, the type of browser you are using on your device, your language preferences or display preferences or the country from which your device seems to be connected to the web.

Please note that by refusing or deleting functional cookies that are required to browse our website effectively, you may degrade your website navigation.

The banner shall include, among other things:

- identity of (the) data controller(s);
- purpose of your personal data processing ;
- tracers / cookies lifespan ;
- possibility to withdraw your consent at any time.

In accordance with “deliberation n°2020-092” of 17 September 2020 adopting a recommendation proposing practical ways of compliance in the event of use of "cookies and other tracers" of the CNIL, you must be able to accept or refuse the use of tracers with the same degree of simplicity.

To this end, you can click on a button to refuse the deposit of cookies which has the same format and is placed at the same level as the button to accept the deposit of cookies.

- To ensure that your consent is free, informed and unambiguous, the banner will not disappear until you have accepted or refused the cookies.
- Unless you give your prior consent, the deposit and reading of tracers will not be carried out:
- if you visit the Site (home page or directly on another page of the website) and do not continue the navigation: a simple absence of action cannot indeed be equated with a manifestation of will on your part;
- or if you click on the link in the banner that allows you to set cookies and, if necessary, refuse to accept cookies.

VIII. HOW TO MANAGE / DELETE COOKIES FROM OUR BROWSER AND FORM MOST COMMON BROWSERS ?

The use of cookies requires your express prior consent. You can still subsequently withdraw your consent and block cookies and/or delete them at any time, by changing your browser preferences.

If in your browser you have agreed to accept cookies on your device, the cookies embedded in the pages and content that you have viewed may be stored temporarily in a dedicated space on your device.

They can only be read by their issuer. You can also at any time configure your browser to accept or block cookies one by one when offered, before they are saved to your device.

How to enable, disable and delete cookies depends on your device and your web browser. Simply go to your browser's help menu to see how to change cookie preferences.
