WFS COOPERATES WITH JETPAK TO OFFER FIRST AND LAST MILE DELIVERIES FOR CARGO AND E-COMMERCE ACROSS DENMARK

WFS' EFFH services make freight Readyfor-Carriage, capturing weight and cargo measurements, and providing security screening, consolidation, and transportation to and from handling agents. The solution also covers deconsolidation, sorting, and preparing shipments for customs clearance, plus onward transportation by road, as well as shipment labelling, repacking, crating, and customised screening services.
